# Challenges

## Building a scalable and reliable solution for access controls

As a rapidly expanding financial technology company, Loop considered having a scalable and secure authorization solution in both the front and backend to be of the utmost importance.

In pursuit of centralized access controls that would enable secure operations, efficient servicing of a growing customer base, and ensure compliance, Mohsin Kalam, CTO and Co-Founder of Loop, sought a battle-tested solution.



*“Authorization is something that we take very seriously, because we deal with financial transactions. And we wanted to make sure that we have something that’s battle tested for our company and we didn’t want to reinvent the wheel.”, Mohsin explains.*

Recognizing the exorbitant cost and time associated with building an in-house authorization system, Mohsin knew that developing a solution from scratch was not a viable option.



*“If we would’ve had to do it on our own, then I know that we wouldn’t have been able to scale, as we are now, with the confidence that we have. And we especially would not have been able to meet the compliance of our regulators as quickly.”, Mohsin adds.*



The team at Loop sought a third-party access control solution that would allow their development and engineering teams to focus on releasing faster while expanding their customer base.

After evaluating various authorization providers, Loop ultimately selected Cerbos as their authorization system developer.



**“The team at Cerbos are great, receptive people. The APIs were easy to understand, and it was more of a plug and play solution. We did a quick prototype and didn’t have any challenges. ## Solution

### Scalable and secure authorization layer

Mohsin was impressed by how quickly and easily authorization through Cerbos could be set up, enabling Loop to roll out their authorization solution in just one week.

Using the API documentation and the step-by-step instructions, the team at Loop was able to set up the architecture.



*“The thing I love about Cerbos, is that you can just work it as an open source dockerized container - just need to pull in the latest image and boom, you have a server deployed.”, Mohsin says.*



After that, Loop's engineering team collaborated with the Cerbos developers to define policies for Loop's use case. Non-technical team members from Loop were likewise involved in the process, seeing as the YAML in the policy is so easy to use.

*"And after that, it's just been smooth sailing.", Mohsin says.*

After setting Cerbos up, Mohsin noted that Loop only touch their authorization when they need to add or update a policy. Additionally, Cerbos gave Loop confidence in their operations thanks to the comprehensive audit logs.

Cerbos has helped Loop swiftly meet compliance requirements, with the solution functioning in both the front and backend.



*"Cerbos definitely helps us meet compliance. Some of the compliance checks require us to have security policies up to date. Being able to demonstrate that Cerbos is handling authorization for us is a great convenience.", Mohsin highlights.*

The clean architecture and documentation of Cerbos have earned praise from Mohsin, as has the exceptional support provided by the Cerbos team during the implementation stage. By implementing Cerbos, Loop has saved time on development while enhancing the security and scalability of their business.



*"We have Java in our tech stack, we have NodeJS, we have ReactJS. Cerbos integrates with all of them really well, because it works on an API level basis. You ask a question and it returns an answer. So it doesn't matter what the consuming technology is, it just works. Having a clean architecture where both the frontend and the backend teams can work independently, but still have a central point, is valuable to us.", Mohsin says.*

### Security, compliance, and quicker releases

*“We were actually able to focus on other parts of the pipeline and other parts of the software development life cycle. So, speed to release has been impacted, which meant that we could service more customers much faster. Having more releases done, having more time to do experimentation, is also a really good win for us.”, Mohsin highlights.*
